We also will not be held liable for any injuries to any animal while being trained off the property, during field trips, veterinary visits, including loading and unloading from vehicles. If the animal's health demands quick action, Right Paw Forward LLC is authorized to have a veterinarian look at and treat the animal for the injury. The owner shall pay such expenses, being reasonable in amount, promptly. If the dog is not physically sound, the dog will be returned home until he is physically ready to meet the demands of training.
